#### 4. Reports:

**4.1** COABE Report Out: Adele shared some members attended the COABE National Conference was great to see things from a national view. Adele said it is helpful when you apply for grants like the WIOA grant because things are different in other states. She mentioned digital literacy was a theme throughout the conference and funding opportunities. It was an opportunity to collaborate. Martha said one of the major take away was to have an opportunity to share about our programs with the State Director and Program Monitor. Adele shared that they have been invited be a pilot program by the State Director.

#### **4.2** Member Updates

**Apple Valley Unified School District:** Adele McClain said they are hosting one construction program. They are expanding the CTE courses. They are bringing a digital literacy class. Adele explained two positions have one full-time teacher. Adele was able to hire a student as a resource navigator. Adele shared that her number of graduates will be lower, but her persistence is higher.

**Hesperia Unified School District:** Kim Walker said they are in full mode for graduation. They were on the phone with CASAS about an error, which is an error across the state—they are also working with the ESL classes now level 3A and Level 3B into two courses. They are planning enrollment for July.

Lucerne Valley Unified School District: Adele McClain said three more graduates than last year's total of ten graduates. Lucerne now has a permanent building and a

gate. She said they can now CASAS test all day long to assist with payment points with pre and posttest. Lucerne teachers have been training to utilize the CASAS data to drive instructions.

Snowline Joint Unified School District: Chad Brooks said they have 16 students graduating, maybe a total 24 students, just excited about 24. ESL/ABE try to offer ESL and ABE classes on both sides of the district. Chad mentioned that are excited to provide a pathway for students in hopes they can take the next step and enroll with the college.

Victor Valley Union High School District: Lorraine Collins said they are busy and excited about graduation. The numbers are lower for them, but it is the same across the state. However they are excited about the numbers they have now. They also attended COABE; she specifically shared about EL Civics. They learned about changes in the law in the State of California. CASAS participated in a pilot for the online math. They have updates on fiber to speed up on the CASAS because it has been a problem, and overall excited about students' success.

Victor Valley College: Dr. Todd Scott shared updates for VVC. They just moved into administration building 55. The college is ready to do the non-credit commercial driver's license program to start in the summer. VVC just purchased equipment for Cosmetology Program that will be launched at the VVC. They also offere Forklift training through a Metallica Grant and had a great response. It will move towards a noncredit course. VVC is hiring 13 new full-time faculty members. The nursing department is changing a few prerequisites; they will now require CNA classes. They are exploring the idea of one or two bachelor's degrees. One of them involves Substitute Teaching Credential and possibly a Respiratory Therapy bachelor. The ASB President Pamela just won a State award regarding student needs. In June, a noncredit director will join us. Justice-Involved Program found out that there are 1500 inmates released into the High Desert every day. Enrollment at VVC continues to rise, it really is about all the hard work going on campus. Ramabassadors are calling students who have not come back. VVC is really focusing on one email and one phone call to get connected to get service. Dr. Scott thanked Dr. Williams on the Ram Center and would like to replicate it on other school sites. VVC will be breaking ground on an education event center and a football stadium. The VVC board just approved the idea of exploring student housing. Rebecca Monjaraz shared that she is visiting campuses and providing workshops and orientation workshops. She said all are welcome to join, and she is doing workshops bilingual. Dual enrollment has been really exciting because it has been growing, and more students show interest in that. A highlight is that there is a student meeting AB 540 status and can now take classes at VVC. The coordinators of each site shared they are grateful to Rebecca Monjaraz for all the work.

#### 5. Discussion Items

**5.1 Three-Year Year Plan: Due June 20, 2022 Review-** Martha provided a brief update on the three-year plan. She shared some of the activities, included a Community

Forum on April 7, 2022. The results will be shared in a few weeks. She shared that they view data from different sources to assist with writing the plan. The plan also includes activities that can be tracked by low literacy.
